4. Community member meetings part 2

- a. Session I & ii Open Space

The session is a joint session between the Post-Award and the e-Delivery Communities. The topics discussed are suggested by the members in advance or during the meeting. The members are urged to send in suggested topics during the morning session and the lunch break and the session starts with the CC leaders presenting the order in which the topics are discussed.
- b. Session iii: e-Tendering Transition in Work Group

This session is a session specific targeting members of the e-Tendering Transition IN Work Groupe, and is to be seen as a work session for the group, focusing on how to setup a production environment for e-Tendering.

5. OpenPEPPOL Member meeting

The OpenPEPPOL member meeting is more than a joint session for the CC members, as it is an open discussion of how to adjust statutes, governance model and finance model of OpenPEPPOL to cater for both scalability and stability of the association.



The member meeting covers 2 main topics:

a. Introduction to suggested changes of Governance Model and Statutes

Here the OpenPEPPOL Managing Committee will present their take on how to revise the Governance model and operational structure of OpenPEPPOL, and how to revise the statutes to implement these changes. An introduction that is aiming to cater for an open dialog with the members about how to change the association structure operationally and structural to simplify, secure and optimize processes and procedures of the association.

This part of the member meeting is to be seen as preparatory to voting item 5 and 6 a at the 9th GA, as well as input to the Managing Committee in how to operationalize and implement a revision the Governance structure.

b. Discussion of the future financial model

Based on an example on how the financial model could look in the future, there will be an open discussion of how to secure a sufficient financial basis for OpenPEPPOL to operate the administration and infrastructure Operation going forward.
