News from MC

Membership Status – 25.04.2022

- Global Growth
 - Projected Annual Growth decreasing – 2021 5,76%, March 14th 13,82%, today 8,73%
 - Europe is the main source of growth in 2022 (62%) but the trend is for the mix to change in favour of non-European membership
- Growth in countries
 - Japan is the main source of growth (5 out of 13) – UK (3) coming right after
 - Norway is the biggest country in number of total members (59). Italy lost members at the end of the year and was left behind (55 members)
 - Negative growth for New Zealand and Singapore (-1)
- Member acquisition trends
 - Number of MAF requests has increased in 1st quarter 2022
 - 23 in 4th quarter 2021, 29 in 1st quarter 2022
 - However, incoming member trendline is slightly below 2021
- Peppol Network Growth
 - 623.748 receivers in March 2022

Development update

- **Japan**
 - Training provided to JP service provider community (45 participants/session)
 - Meeting scheduled for 4th May to demonstrate pilot test environment to SPs
- **Canada**
 - Follow up call held with Tax Administration
 - interested in Peppol CTC model, but emphasised that policy rests with Dept of Finance
 - unable to attend Miami event this year but open to speak at future Exchange Summits
- **Service Provider survey**
 - issued 28th March, 30 responses received, closing date extended to 29th April
- **peppol.org website launched**
 - most issues quickly corrected and an improvement list is being worked through
- **Netherlands/Poland Chamber of Commerce**
 - participation in newly formed Knowledge Circle (NL and PO PAs briefed)
 - expected eInvoicing webinar later this year (170 members, significant businesses e.g. Shell)

Incubation proposal from BEAst – SE construction Industry

- For a number of years. BEAst has been given the opportunity to exchange its bespoke documents over the Peppol Network
- An early-date version of Extended Use requested by the SE PA but never wanted the status of a National Service Domain
- Recently they have been moving to UBL and to Peppol-compliant documents. They request incubation status so they can be more flexible and avoid long lead times that come with PoAC
- They work on an improved Despatch Advice and other documents in the future
- Incubation proposal available on Confluence ([posted here](#))
- There is a need to join forces with NOROG (Norwegian Oil and Gas Industry), which wants to work on an Advanced Despatch Advice and other business documents opening the door towards a Logistics Service Domain
- **Decision**
- *The BEAst proposal receives the MC pre-approval, according to the Policy for Extended Use of Peppol*
- *BEAst is requested to proceed with a more detailed Incubation Charter. In the meantime, BEAst can continue its work according to the incubation proposal.*
- *In this effort, BEAst is requested to cooperate with NOROG and aim to present a joint approach with a view to establishing a new Peppol Service Domain in the area of Logistics.*

Market News

BPC - Status and next steps

Status update

- The Market Pilot is progressing according to plan. The first connections are, reportedly, about to take place
- Governance work has started
 - The Policies, Rules and Guidelines sub-committee is activated
 - The governance framework is being designed from scratch, main references being GIF and the SoA work group active in the previous phase of the BPC project
 - The policy areas will be quite close to what Peppol does. The Peppol governance document are used as background material

OpenPeppol strategy

- The BPC Semantic Model is much wider than Peppol, even wider than the EN
- Peppol can work with it in the way it worked with the EN and create a compliant CIUS as BIS Billing 3.0
- The PINT PoC project is working on a proposal

EESPA cooperation - Next steps

- A document version of the Terms of Reference to be produced

Consultation – Terms of Reference

- EESPA would like to send them to its members on 13 May 2022, to be approved at their upcoming GAM
- MC approval will be needed before then – ToR to be provided to OpenPeppol members and particularly to PAC and SPC

Decision – Full incubation proposal

- Develop the full incubation proposal, including the required references to the approval criteria as laid out by the policy on Extended Use of Peppol
- Consultation of members
- Final decision by both Associations expected in June.
