#### **Code List states**

- State "Active"
  - Active entries are introduced by the release of a new version of the Code Lists
  - From the effective date of the Code List release, new entries can be used
- State "Deprecate"
  - All Active entries can transition to the state Deprecated upon request
  - The state Deprecated is introduced with a new Code List release only

Active

- Deprecated entries can transition back to Active state
- State "Removed"
  - Only Deprecated entries may transition into Removed state
  - Removed state is indicated with a new Code List release, based on a particular date in the future (at 00:00 UTC on that date)

### Participant Identifier Schemes

- State "Deprecated"
  - Registrations of new SMP Service Groups that use a Deprecated Participant Identifier Scheme, is forbidden
  - Migration of Service Groups between SMPs is still allowed
- State "Removed"
  - No SMP Service Group registration using a Removed Participant Identifier Scheme may exist
  - No exchanged Peppol Dataset may use a Participant Identifier that uses a Removed Participant Identifier Scheme
  - It's possible to centrally enforce this policy
- Many dependencies (ISO ICD list, EU EAS list, Peppol Domains, Peppol network specifications, SML)



## **Document Types**

- State "Deprecated"
  - New SMP Endpoints are not allowed to use a Deprecated Document Type identifier
- State "Removed"
  - No SMP Endpoint may refer to a Removed Document Type identifier
  - No exchanged Peppol dataset may use a Removed Document Type identifier
- Depends mainly on Peppol Communities and Peppol Authorities



#### **Processes**

- State "Deprecated"
  - New SMP Endpoints are not allowed to use a Deprecated Process identifier
- State "Removed"
  - No SMP Endpoint may refer to a Removed Process identifier
  - No exchanged Peppol dataset may use a Removed Process identifier
- Depends mainly on Peppol Communities and Peppol Authorities



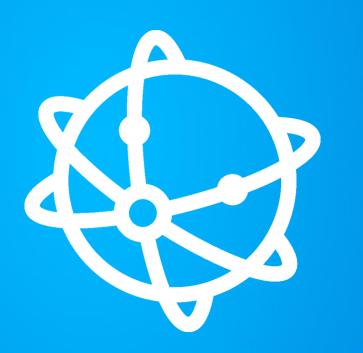
### **Transport Profiles**

- State "Deprecated"
  - New SMP Endpoints are not allowed to use a Deprecated Transport Profile
- State "Removed"
  - No SMP Endpoint may refer to a Removed Transport Profile
  - No exchanged Peppol dataset may be exchanged via a Removed Transport Profile
- Usually strategic decisions only



### Next steps

- Finalize the respective guideline
- Clarify the exact actions needed for all stakeholders for each state change in each code list
  - Including minimum migration durations etc.
- Evaluate the impact of the Internal Regulations on the processes
  - Each code list change may get a member review
