- The ESPD is a **standardised** self-declaration of the potential supplier's financial status, abilities and suitability for a public procurement procedure.
- The ESPD is a **legal requirement** throughout the EU/EEA for tenders with an estimated value equal to or higher than the thresholds for European publication, introduced in article 59 of the Public Procurement Directive 2014/24/EC.
- Commission Implementing Regulation (EU) 2016/7 establishes the standard form for the ESPD.
- The ESPD can be a used as a standalone document but is most frequently used together with other procurement documents. It is typically built-in as an integral part of procurement systems used in European public procurement processes.



- Provides a standardized way for:
 - a Contracting Authority (CA) (the buyer) to express their procurement objective, complete with applicable Exclusion Grounds and Selection Criteria relevant for the procurement procedure in an ESPD Request, and for
 - an **Economic Operator (EO)** (the seller) to respond to the stated Exclusion Grounds and Selection Criteria in an **ESPD Response**.




- The **ESPD Request** will typically be made available by the CA as part of the call for tender documents.
- The **ESPD Response** will typically be made available by the EO as part of its tender.
- The ESPD Request and ESPD Response may however also be exchanged as independent business transactions.

- EC has developed a data model and 'semantic assets' for the exchange of the ESPD between any procurement stakeholder's system and it maintained by the Publications Office
- ESPD-EDM (Exchange Data Model)
- version 3.0.1 Road Map





A little bit of history...

- PEPPOL LSP project (2008-2012) and Virtual Company Dossier (VCD: interoperable electronic document solution to support the exchange of evidences across borders.
- e-SENS LSP project (2013-2017) VCD/ESPD implementation intended to support the creation of artifacts needed for the qualification procedures in pre-award, awarding and post-award processes.
- ESPDint CEF funded action (2017-2019) and other CEF funded actions: ESPD implementations according to ESPD-EDM and ESPD BIS 41



Peppol ESPD BIS WG

- Last f2f pre-award community meeting in October 2019
- Discussed and DFØ prepared a mandate proposal for a Peppol ESPD BIS WG that was approved early 2020
- The purpose of the Peppol BIS is to facilitate for service providers to implement ESPD functionality according to regulations, standards and community consensus.



INTERPROC Action

- CEF funded action: 1/5/2021-30/4/2022 (will most probably be extended by 6 months)
- The main objectives of the Action are to:
 - implement eForms
 - develop a Contract Register
 - update procurement services with the latest version 3 of the ESPD EDM and establish interconnection between the ESPD services and national databases and eCertis (Activity 6)
 - implement in the German and Portuguese eTendering systems additional pre-award profiles.

INTERPROC Action: ESPD activity

- Activity 6: Implementation of ESPD services
- The objective of the activity is to **prepare the analysis and technical specifications** and to **upgrade** existing ESPD services to the latest version 3 of the ESPD-EDM.
- The ESPD services will be connected to eCertis and also to national databases for the retrieval of evidences, where this is relevant.



INTERPROC Action: ESPD tasks

- Task 6.1: Business Requirements and Usage Scenario Design
- Task 6.2: Development of ESPD profiles
- Task 6.3: Implementation and put into production new or updated ESPD services
- Task 6.4: Interconnection of the ESPD services with national databases
- Task 6.5: Conformance, documentation and handover for production




INTERPROC Action: ESPD profile

- Task 6.2: Development of ESPD profiles
 - This task will make use of the analysis and requirements elaborated under Task 6.1 and will develop fully implementable specifications including transaction, information requirements, business rules, syntax and an optional transport binding to the Peppol eDelivery Network.
 - The specifications will be made available to the Peppol pre-award community for review, possible revision and eventual adoption as a Peppol BIS.




Available Peppol BIS in the preaward domain





ESPD business process






ESPD business process

- An ESPD Requesting Party, typically a CA, sends or makes an ESPD Request available to the ESPD provider, typically an EO.
- The ESPD provider prepares the ESPD Response and send or makes the ESPD Response available to the ESPD requester.
- Pre-condition: The ESPD requester, typically a CA, needs an ESPD as part of a procurement procedure.
- Post-condition: The ESPD Requesting Party, typically a CA, has received an ESPD Response



Application context for the exchange of ESPD Request & ESPD Response






ESPD BIS

- The Business Interoperability Specification (BIS) document is based on:
 - the ESPD-EDM version 3.0.1 published by the Publications Office and
 - BIS 41 (based on ESPD EDM v2.x.x) developed by ESPDint.
- The ESPD-EDM is licensed under the terms of EUPL-1.2 license.
- ESPD BIS:
 - Profile
 - Transactions
 - ESPD Request
 - ESPD Response



Relationship between the ESPD-EDM and ESPD BIS





- Gap analysis between of ESPD EDM v2.x.x and v3.0.x
 - Actually, in the ESPD EDM v3.x.x technical handbook there are reference links pointing out directly to the reference codes of the business rules that are documented in the BIS 41.
- Identification of the sources



• Review of ESPD BIS 41

- Check for missing business rules
- Check for incorrect business rules
- Check for extra business rules
- Business rules grouped in 3 categories
 - Common rules
 - ESPD Request rules
 - ESPD Response rules
 - BIS 41 rules used as a basis



- Semantic model and syntax binding
 - UBL 2.3
 - Approach with iterations
 - Start with initial message structure (business rules, semantic model, syntax binding), and documentation
 - MVP (minimum viable product)
 - Validation rules will start with a shallower approach (criteria and structure), and gradually evolve into a complete structure representation
 - What is not there yet is the full requirement group/question group criterion structure



- Codelists used are the same ESPD-EDM v3 provides
 - Transformation of GC XML codelists to YAML files that can be read from the PDK tool
- New rules alongside with rules from the ESPD BIS 41 and the ESPD EDM V3.x.x were combined into one set of Schematron files.



- Management of ESPD via GitHub repository
- Transfer ESPD profile into PEPPOL format using ASCII Doc
 - ESPD-EDM v3.01.
- Syntax Mapping of ESPD-EDM to OASIS UBL v2.3
 - urn:oasis:names:specification:ubl:schema:xsd:QualificationApplicationReques t-2
 - urn:oasis:names:specification:ubl:schema:xsd:QualificationApplicationRespon se-2
- Development of additional artifacts like Examples, Schematron Rules, etc.
