Purpose of the Informative Session

- The 15th General Assembly (GA) of OpenPeppol AISBL will be conducted entirely online as foreseen by Belgian law and the OpenPeppol Statutes
- Voting will be done in ‘real time’ using an integrated (LUMI) software platform in conjunction with Zoom
- There is a need to communicate with Members as much as possible to ensure awareness, understanding and acceptance of the participation procedures and particularly the ways to interact with the proceedings during the meeting to:
 - Motivate members to participate in the process remotely
 - Provide an opportunity to candidates running for Secretary General, Managing Committee and Election Committee positions, to address members in advance of the GA
 - Provide a floor to members for asking questions and obtaining clarifications about the process, also on the agenda and decision items, if needed

Overview of procedures

1. Register for the 15th General Assembly

- Complete the Registration Form and send it to ga@peppol.eu by **June 2nd, 2023**.
- The registrant must declare if he/she is authorised to vote on behalf of the Member organisation.
- Those not attending, can complete the Proxy Delegation Form and submit it to ga@peppol.eu by **June 2nd, 2023**.

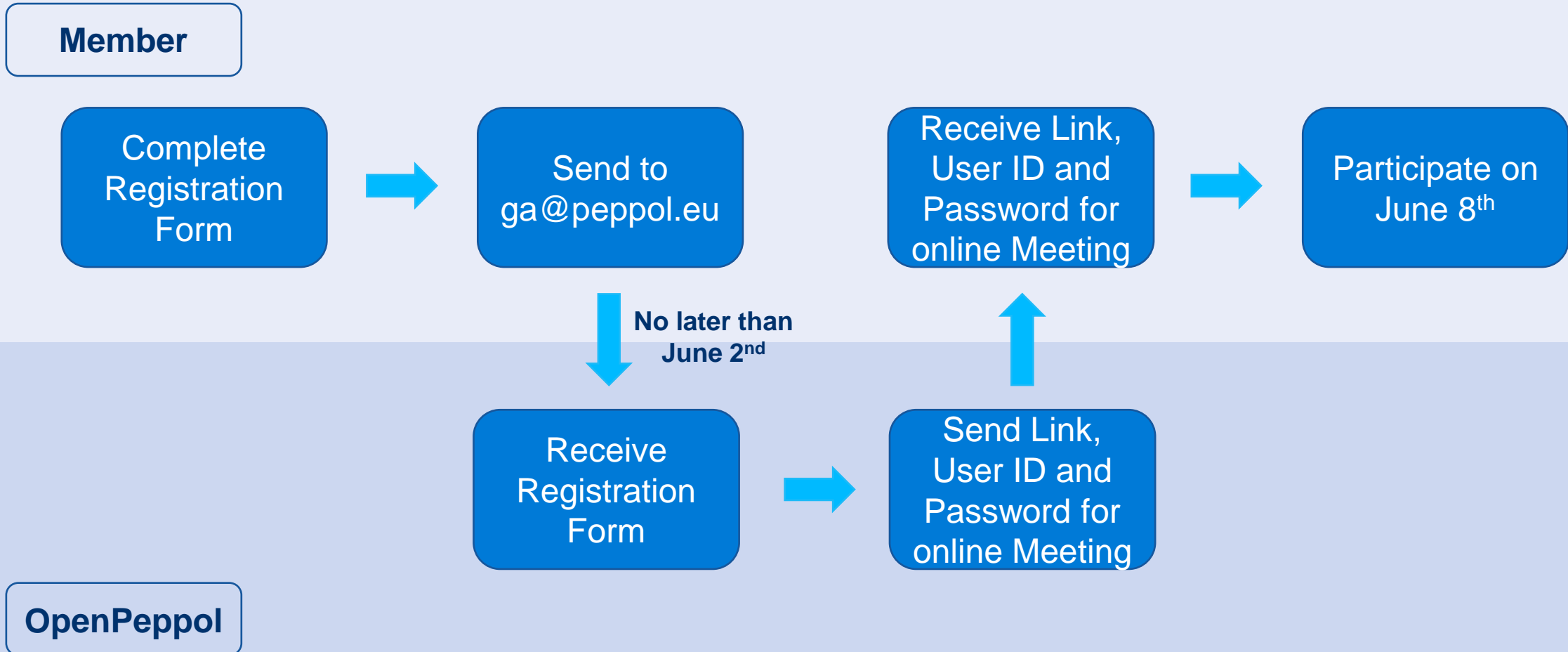
2. Receive the link to the online meeting of June 8th, 2023 (09:00 – 12:30 Brussels time) with a unique user ID and password

- OpenPeppol will register the recipients based on registration forms received and reviewed.
- In advance of the meeting, OpenPeppol will send each recipient a unique ID and password by email along with a link to the meeting.
- **Note:** The user ID and password will be issued to the email address of the person named in the Registration Form.

3. Voting

- Registered Attendees and designated Proxy Voters will vote in 'real time' during the meeting.
- Proxy holders are recognised in the election software with the total number of votes they hold. Therefore they only need to vote once on each item.
- Observers and other non-voting attendees are also recognised, so they are not able to vote.

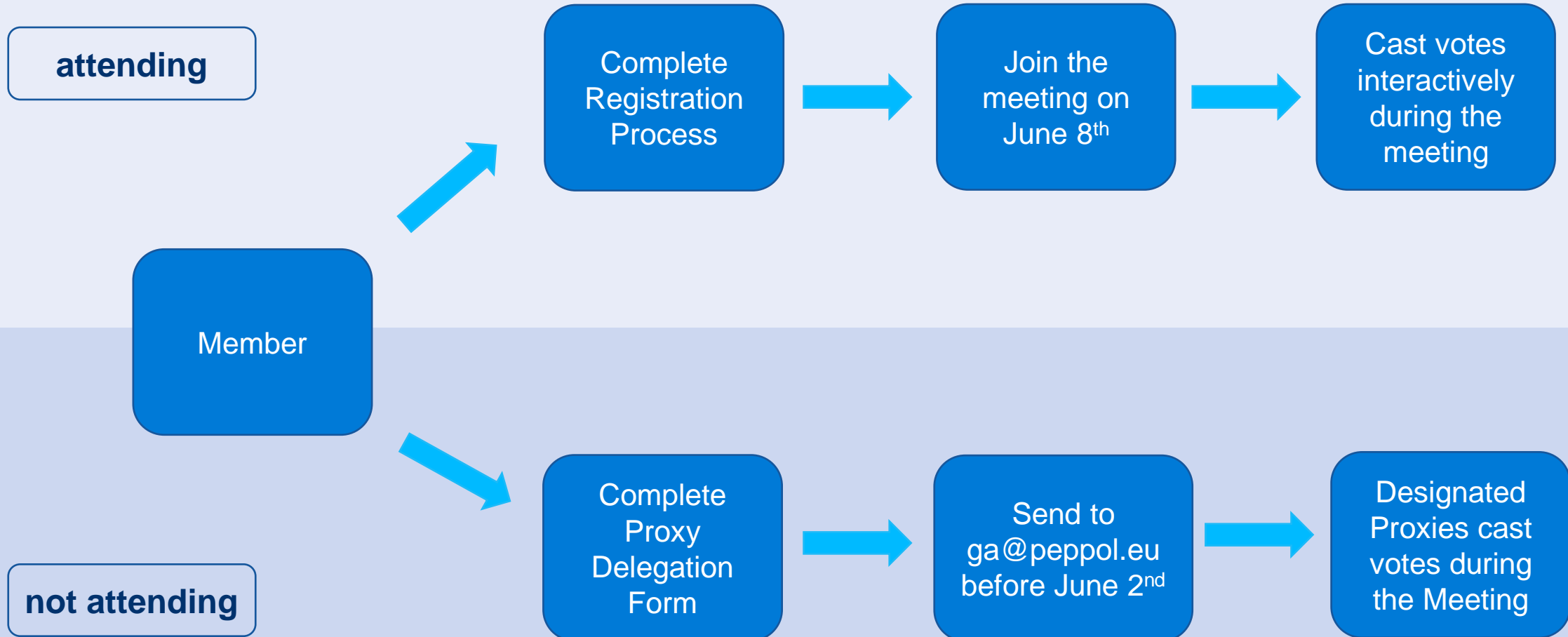

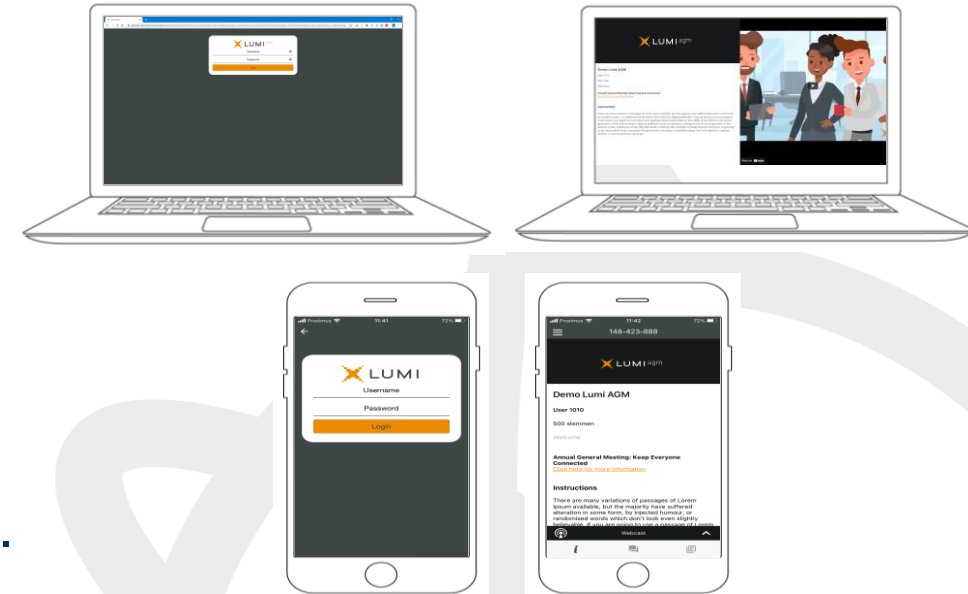

- You will be able to view a live webcast of the meeting, type in questions online and submit your votes in **real time**.



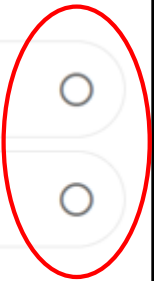

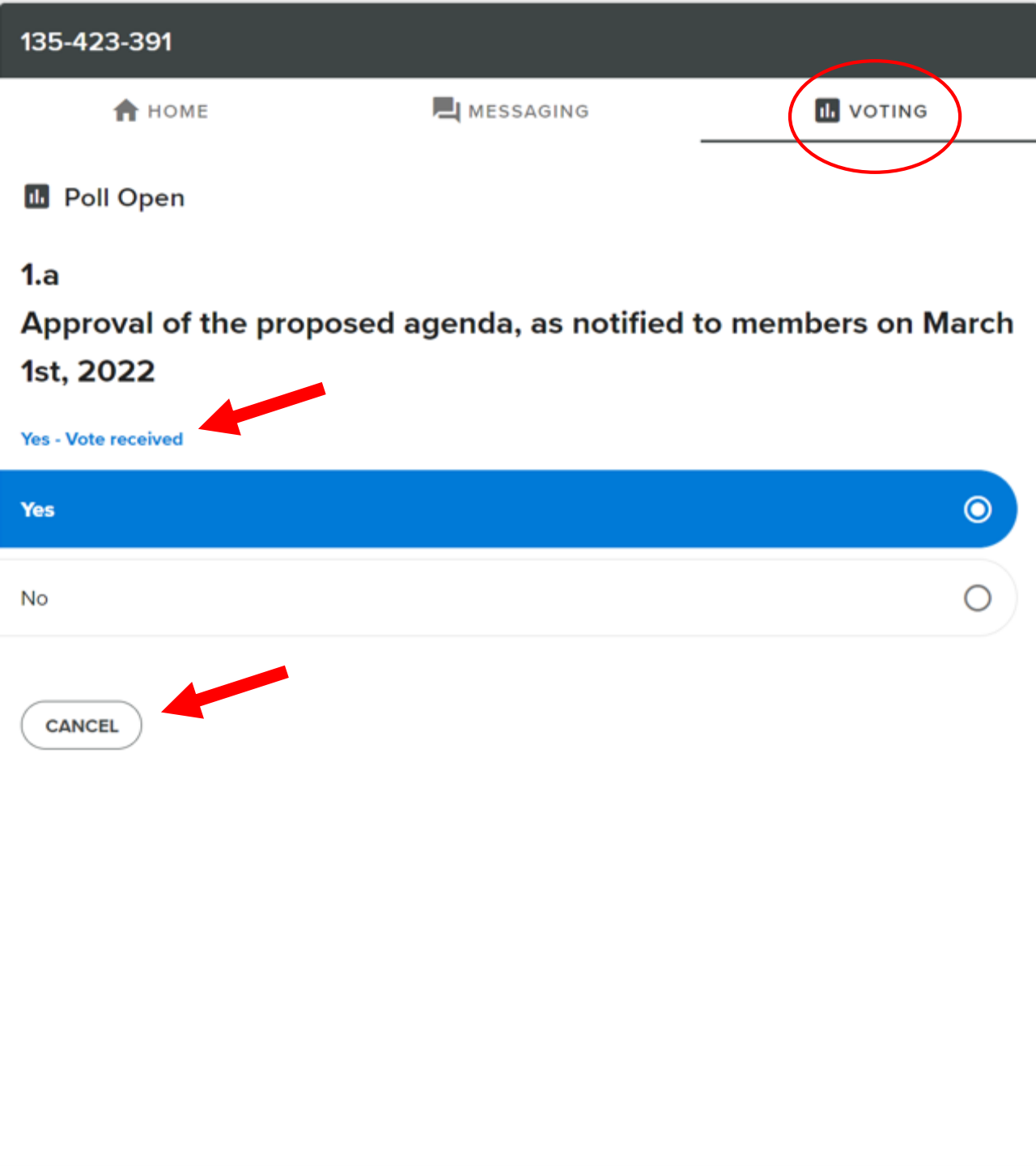


Vote
