The 2023 Call for Candidates in OpenPeppol elections opened on March 28<sup>th</sup>, 2023, closed on April 28<sup>th</sup>, 2023 and extended until May 19<sup>th</sup>, 2023 for the remaining positions. We hereby announce the Candidates presented until May 19<sup>th</sup>. All candidacies have been validated by the Election Committee in terms of completeness and eligibility.

1. Name of Candidate
2. Position(s) the Candidate is running for
3. Name of OpenPeppol Member proposing the Candidate
4. Professional relationship of Candidate and Proposing Member
5. Curriculum Vitae of Candidate (short)
6. Motivation letter, outlining the Candidate's vision for the position(s), for which the Candidate is running.
