

RFC Process

- Varies by document, but generally any OpenPeppol Member or board can submit an RFC. CMB can also initiate change.
- Responsible for recommended changes to MC for:
 - PA & SP Agreements
 - Internal Regulations
- Oversight of changes by Operating Office to:
 - Operating Procedures

- Editorial Changes in Agreements (23 June 2022)
- Annexes to Agreements & IR are not part of change mgmt. (23 June 2022)



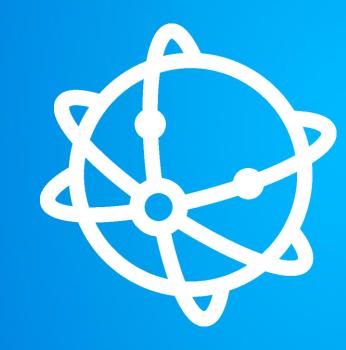
Work Underway

- Removing Semantic Versioning Annex to Internal Regulations
- Restructuring Change Mgmt Policy
 - Simplify wording
 - Add PA Specific Requirements to policy
- Data Collection, Reporting & Usage Policy
 - Enable Reporting BIS
- PA Specific Requirements
 - Constrain PASR on End User information & transaction statistics
 - Ensuring consultation
