Yes	CorpPass KYC CorpPass is Singapore's national digital identity for businesses. The CorpPass KYC helps to validate the authenticity of participants on the network.
Yes	KYC Requirements The Service Providers must get explicit consent from the end-user before they register the end-user on the central SMP. The Service Providers must register senders on the central SMP. The Service Providers must use the CorpPass KYC which is integrated to the central SMP to register Singapore businesses. Exemptions can be considered for Services Providers and businesses on a case-by-case basis.
