Nordic Smart Government & Business (NSGB)

- The pilot was closed on 3rd November 2023
- Participants included 5 tax administrations, 5 central statistical offices and ca 8 service providers
- Only cross-border transactions have been tested
- Some tax administration expressed their interest to have a phase 2 at the beginning of 2024, pending next steps from tax administrations

Singapore

- Singapore have announced that they will leverage InvoiceNow (Peppol) specifications for their own CTC implementation
- The implementation is strongly inspired by Peppol CTC with some localizations, where one of the main deviations is that API will be used towards C5 and B2C transactions would be reported as aggregated file
- Peppol SPs will be required to reaccredit under the new CTC framework
- Unfortunately, if you want to receive more details, this can be done only by contacting IMDA directly, as the materials are not yet openly public, as IMDA and IRAS are still working on the details of the regulatory framework and the technical specifications




Malaysia

- Ideal outcome: Peppol SP considered among authorized channels to validate invoices with mylnvois Portal prior to the exchange
 - This would, however, not be D-CTCE implementation
- Risk: LHDN framework and Peppol/MDEC framework would be completely detached, meaning the benefit of using Peppol would be lowered
- No insights available atm currently, but we know that MDEC and LHDN are in continuous discussions on the ideal solution
 - Hopefully, some announcements will be done either during the Exchange Summit in Singapore or shortly thereafter



Italy

- Informal meeting has been held with the e-invoicing team of the Italian Tax Administration
- Peppol CTC framework has been presented as an option for Italy to comply with ViDA
- The initial reaction was positive, however, we are not likely to receive a more precise response, as ViDA negotiations are still ongoing





France

- The aim is to move forward with a Minimum Viable Product (MVP) which uses a Centralised SMP and the Peppol Directory which largely replicates the requirements of the French Annuaire.
- Out of a total of 51 participants in the PoC 43 responded:
 - 22 fully support and want to participate in the follow-on work
 - 19 support, but reserve their decision to participate, largely awaiting clarification of any financial contribution required
 - 2 do not wish to continue
- At this stage, aiming for a Go Live in Q2 2024.



Spain

- The Royal Decree introducing CTC mandate is expected to be published in Mach-May 2024
- From this moment, a gradual introduction comes into force with phase 1 starting 12 months since the publication of the Royal Decree
- We have initiated question to Spanish service providers whether they would be interested doing a Peppol POC, similar to the one conducted in France
