Any new material or updates existing content hosted on A-NZ GitHub will be consulted on with OpenPeppol and Australian accredited Service Providers and Service Providers seeking accreditation in Australia prior to publication.

1. Applicable or allowed identifier or identification schemes

Applicable	Detailed description
Yes	The Australian Business Number (ABN) is required to be used as the Legal Registration Identifier for Australian buyers and sellers in the invoice document. The ABN is designated using the ISO 6523 ICD list with code '0151'.

2. Information Security

Applicable	Detailed description
Yes	Service Providers must meet information security requirements defined by the Australian Peppol Authority (APA). The requirements may change over time to respond to and mitigate cyber security threats in the digital ecosystem. Guidance Note 03 Information Security on A-NZ GitHub provides clarification and detail on the requirements. This includes the requirement for Service Providers to complete a security questionnaire and provide evidence of meeting the requirements for accreditation and demonstrate their continued compliance to maintain their accreditation.
Yes	The Peppol framework requires Service Providers to ensure End User identification is completed.



Guidance Note 10 End User Identification on A-NZ <u>GitHub</u> details how Service Providers are to complete this for Australian entities. This includes requirements for:

- a documented process for End User identification
- End User authorisation to enable access to the Peppol network
- collecting and/or validating End User information
- annual checks.

3. Reporting on End User information and transaction statistics

Yes	Service Providers must report statistics to the Australian Peppol Authority.
	(note: it is intended that this requirement will be replaced by the Peppol centralised reporting once that is in place and fully operational)
	Guidance Note 07 Reporting Statistics to Peppol Authority on A-NZ GitHub defines how to report to the Australian Peppol Authority. At a minimum, Service Providers must report information about transactions for Australian entities monthly to the Australian Peppol Authority:
	a) number of effective senders;
	b) number of effective receivers;
	c) number of transactions sent per Document Type ID; and
	d) number of transactions received per Document Type ID.
	Reports shall be sent to the Peppol Authority no later than 10 working days following the end of the calendar month being reported.

7. Service Provider Accreditation

Applicable	Detailed description
Yes	Service Providers must be accredited by the Australian Peppol Authority. The accreditation process has been implemented to help protect Australian participants.
	Service Providers must complete the Australian accreditation process. This includes:
	Due diligence checks (including insurance),
	 Security requirements (including a security questionnaire), and
	 Interoperability testing to demonstrate the ability to support the A-NZ specifications
	There will be an annual review of the accreditation status to ensure the Service Providers continues to meet their obligations on an on-going basis.
