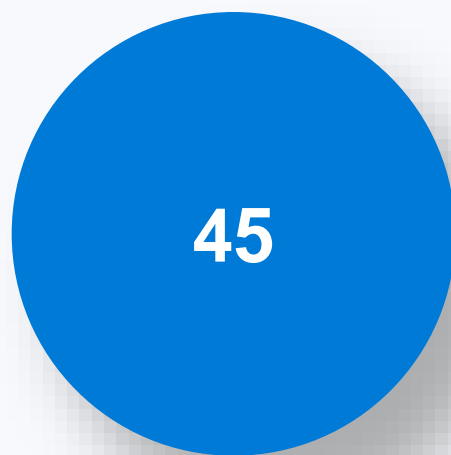

# Key membership indicators

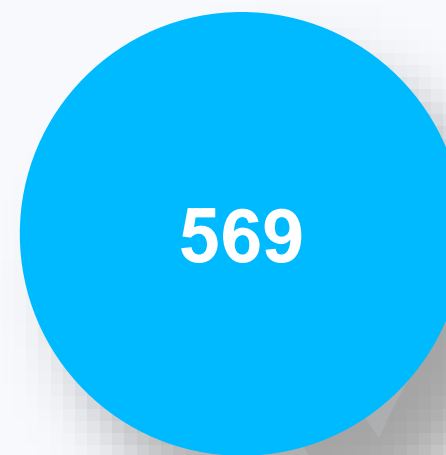


Countries with Peppol Authorities



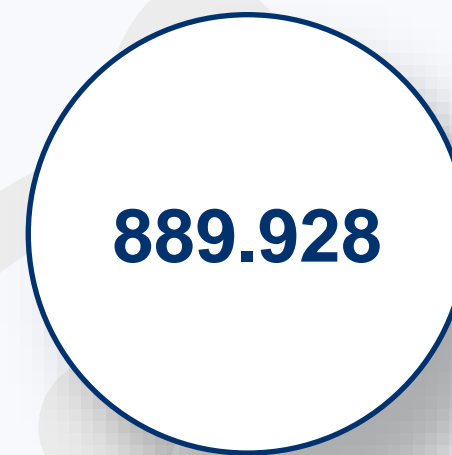
Countries with OpenPeppol members

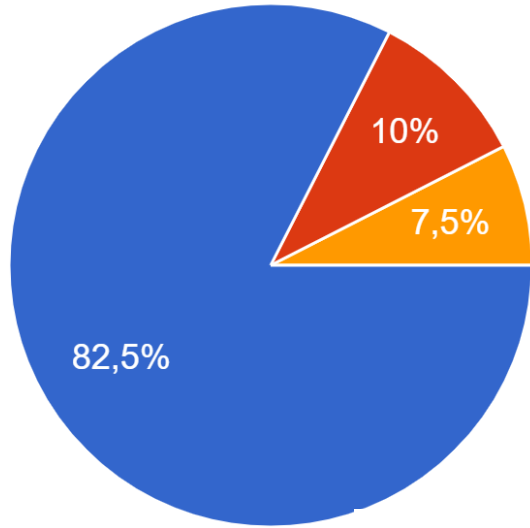
# Survey on Service Provider Community work 2023

# How often do you participate Peppol SP Meetings?

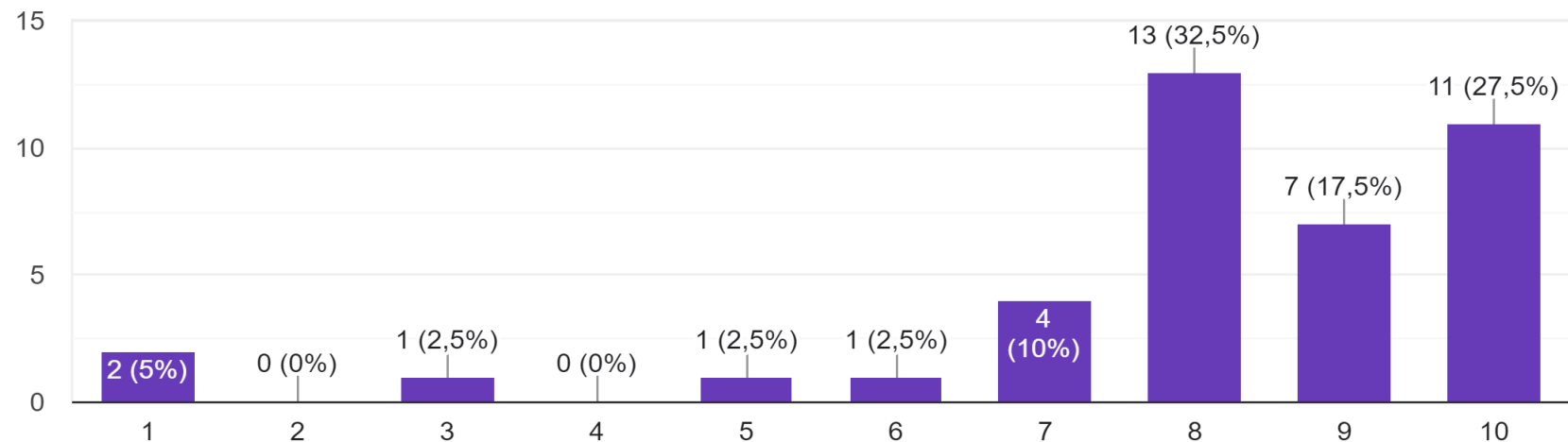

- Kick-off meeting is envisioned to be on Wed April 3<sup>rd</sup>, 8:30 to 10:00 CET

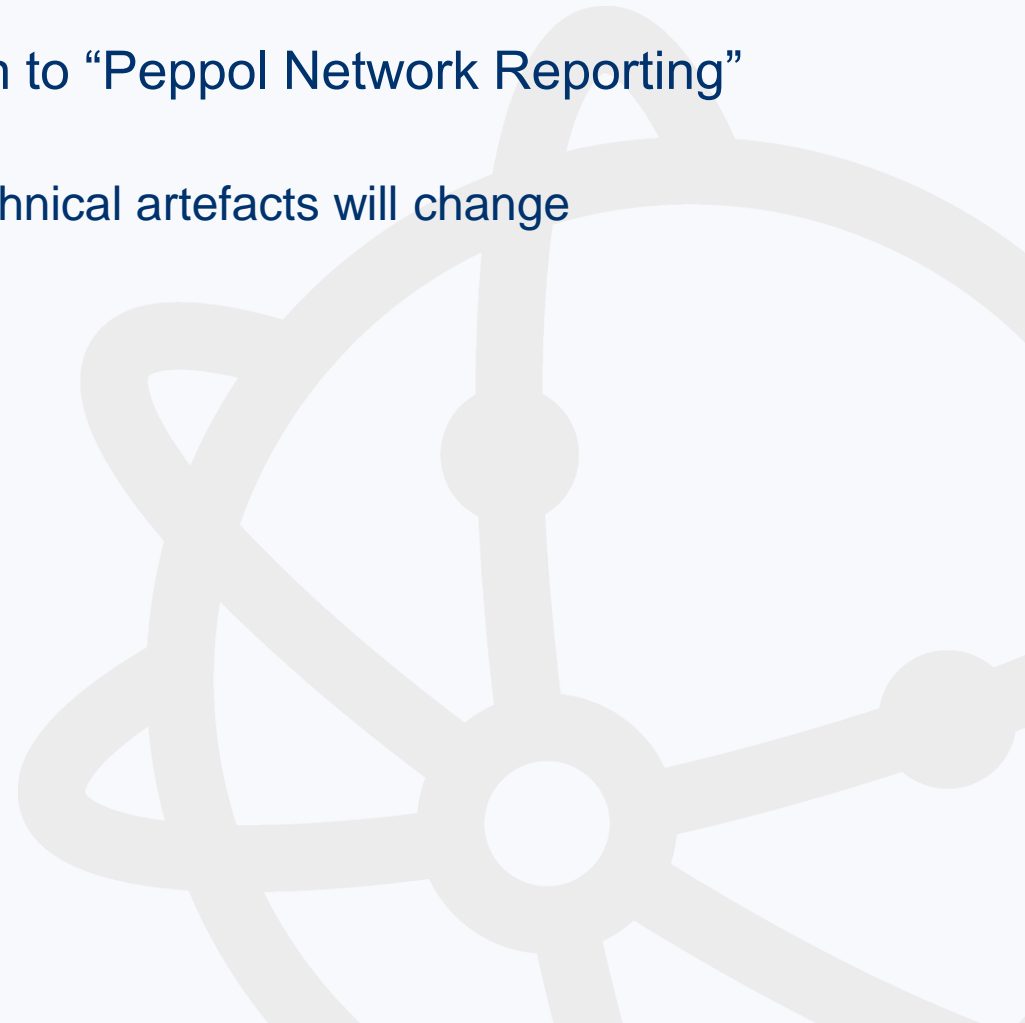


# eDEC Information

## Other News plan

---

- Planned to rename the “Peppol Reporting” specification to “Peppol Network Reporting”
  - Clearly differentiate from “Tax Reporting” and similar
  - Will just be a change in the title and the wording – no technical artefacts will change
  - Will be adopted soon
- eDEC Code Lists v8.8 are to be released soon
  - Including Malaysia PINT IDs and others

# In the pipeline

---

- November release
  - Already out and mandatory
  - Self billing approved
- May release
  - Preparation ongoing by OO
- MLR, IMR, MLA, MLS, ...
  - Workgroup has submitted RFC to eDec for approval
- Country specific rules
  - An informal review by the PA's is done
  - Remarks processed
  - OO reviewing is ongoing
- ViDA activities
  - TC434 is processing the request from the E.C.
  - Revision of the EN16931 due by end 2024
  - Support for ViDA requirements and B2B mandates in the EU

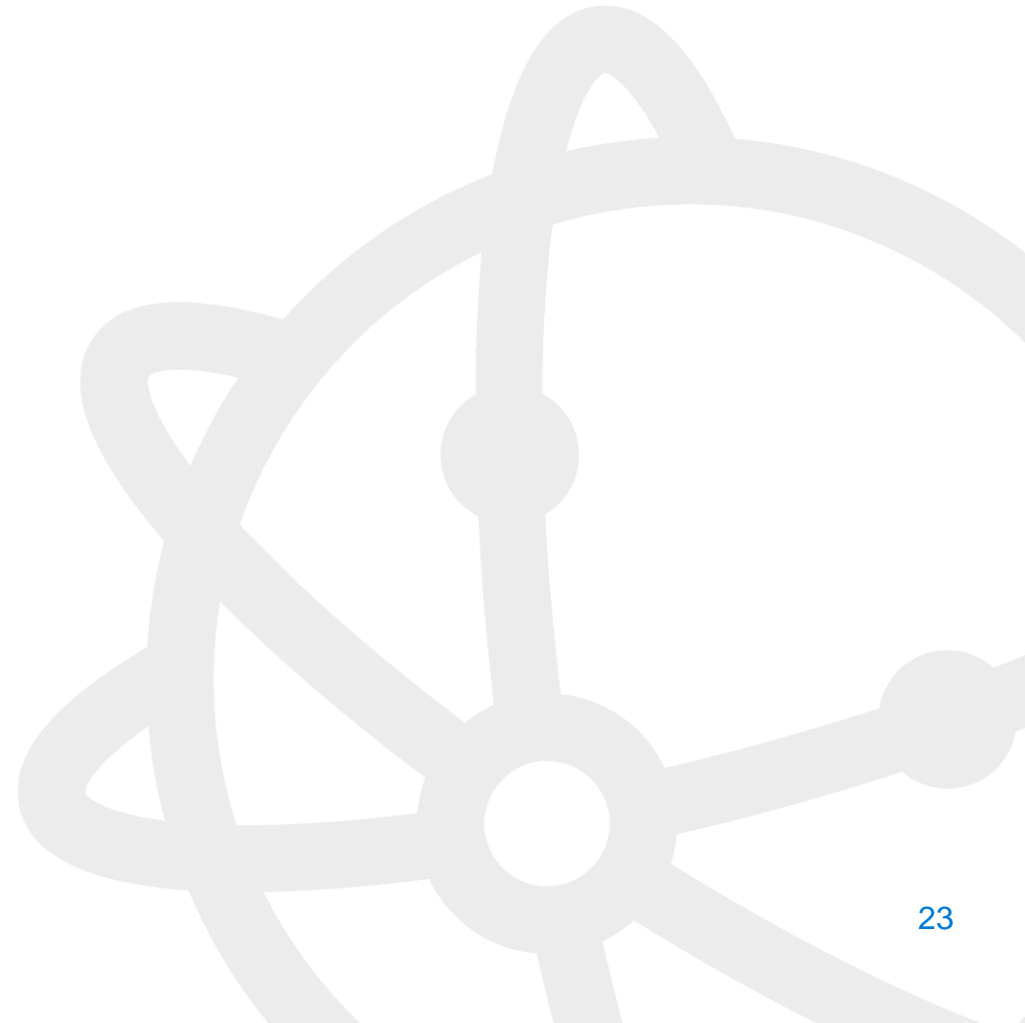

## February:

- 202 SPs submitted both reports
- 61% of the SPs
- Approximately 80% of all traffic is covered
- 125 SPs were reported as non-compliant

## March (so far)

- 235 SPs submitted both reports
- 70% of the SPs

# Global data

---

- Transaction Statistics Report shows the statistics on exchange of documents.
  - Sent and Received is on globale level the same number.
  - Per country this may differ because of cross-border traffic
- End User Statistics Report shows the statistics of End users based on their domiciliation.
  - End Users could be senders, receivers or both.
- Segregation per document type as listed in the code list.
- Segregation per SP according to their Seat-ID

# GENA Incubation Committee

---

# Status

---

- In 2023, the joint incubation project with EESPA (which transformed into GENA) was approved, and started making progress. In 2024, the first results will become available, and the eventual conclusion will start to come in sight.
- The technical specifications of a Starting Environment will be concluded in the early part of 2024 and the possibility that the incubation project can go into production in 2Q2024 remains desirable and feasible.
- The outline of an organisational and governance model of closer cooperation between OpenPeppol and GENA, linked to a successful conclusion of the incubation project, will be available in spring 2024 and will be discussed with OpenPeppol Members
- The Incubation Monitoring Committee will be activated there is progress to review – the SPC should appoint at least one new representative to replace Trond.

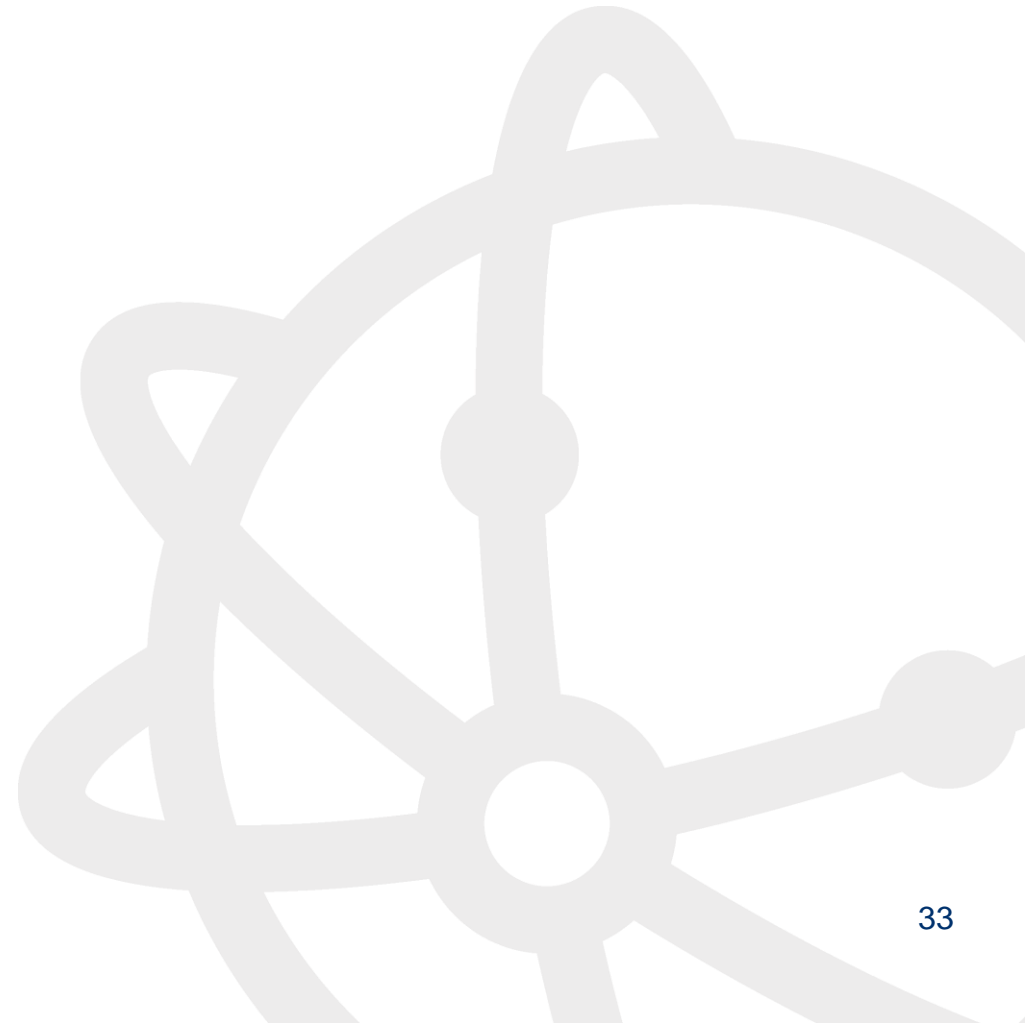
