

Peppol going global

- South-East Asia
 - Singapore: Official launch was in January 2019
 - The first PEPPOL Authority outside Europe
 - Helping to engage other ASEAN countries
 - Malaysia may be next hopefully by early 2020
- Trans-Tasman region
 - New Zealand already joined, Australia joining soon
 - The two countries coordinate and align their requirements
 - Planning to go live late 2019
- How do we engage other regions?
 - Establish understanding of the PEPPOL approach
 - Formulate value proposition on focus (eg marketdriven/government-driven)
 - Accommodate regional requirements, maintain compliance with Peppol principles












New Zealand

New Peppol Agreement Framework

To be approved by 27.1.2020 Migration starts 1.2.2020

Autumn 2019

- Peppol role in tax compliance support to be established how should Peppol BIS and the Peppol
 eDelivery Network best be used to support tax clearance and tax reporting models?
- International invoicing work group to be initiated result expected for autumn release 2020



Peppol BIS Billing 3.0 migration status

Where do we stand as of 30 September

- 394.076 service groups (participants) were scanned in the SML
- 166.874 still only use the old BIS 1.0 or BIS 2.0
- 1994 use no BIS documents at all
- 42,3 % of the receivers in the SML are not using the mandatory Peppol BIS Billing 3.0



AS4 migration status

Where do we stand as of 14 October

- 290 total service providers in scope for AS4 (251 Certified providers and 39 new providers)
- 31 have done the AS4 certification test
- 25 Service providers are currently doing the AS4 test
- 234 have not started the AS4 test yet!

Preparation of final draft agreement documents	November 15 – 22, 2019
MC evaluation of final draft agreement documents	November 22 – December 20, 2019
PA to document and get approval of their "special requirements"	November 22 - December 20, 2019
PA formal approval of final draft agreement documents	January 1 – 27, 2020
Publication of revised Agreement Framework	January 31, 2020
Migration initiation	February 1, 2020 >



Tax compliance – support for clearance and reporting

OpenPeppol position to be established

Tax clearance

- With a clearance model for elnvoicing, the tax administration requires each invoice to be reported and authorised electronically by them before or during the exchange process
 - 1. The tax authority requires to be involved in the issuance and receipt of elnvoices
 - 2. There are different invoice formats and validation rules required in clearance models
 - 3. Usually the message exchange process (from supplier to buyer) is not regulated

Tax reporting

- With a tax reporting model for elnvoicing, the tax administration requires a real-time copy
 of the invoice as part of the message exchange process, or as a batch sending
 - 1. The tax authority mandates the real-time or batch reporting of all invoices, distributed ledger technologies are also starting to be mandated
 - 2. There are different invoice formats and validation rules required in reporting models
 - 3. Usually the message exchange process (from supplier/buyer to tax authority) is done tax authority specific



International invoicing

Work Group to be established

- Pre-study completed by OpenPEPPOL Work Group in June 2019
 - Participation from Europe, North-America, Asia and Oceania
- OpenPEPPOL Work Group on international invoicing established Autumn 2019
 - Open for OpenPEPPOL members to participate
- Overall goal to establish a PEPPOL international invoice framework by autumn 2020
 - Shared fully defined
 - Aligned: Generalised → Specialised
 - Distinct content
 - Hierarchical layering




