Specification (BIS) Update

- Version 1.0-RC2 published at https://docs.peppol.eu/pracc/
 - Added the Pre-Award eDelivery Guide and Pre-Award eDocuments Guide
 - Created the pre-award schematron Package and made it available for download
 - Removed deprecated schematrons from all the transactions (T001 T006)
 - Applied rule eSENS-T004-R007 in issue time in Call for Tender Syntax
 - Applied missing rule eSENS-T004-R029 in procurementProjectLot/ID in Call For Tender Syntax
 - Applied missing rule eSENS-T004-R024 in additionalDocumentReferenence/ID in Call For Tender Syntax
 - Applied missing rule BII3-T83-R008 in cac:TenderingProcess
 - Removed wrongly referenced T90 and CL90 business rules in Call For Tender
- If no issues found RC2 will become version 1.0.0



Pre-award Specification Status

ISA Testbed update

- ISA Testbed now can automatically be updated by PEPPOL
- The new schematron artifacts from RC2 have been deployed
- Tested internally and found OK
 - First reports also from CEF Implementors are positive
- In communication with ISA Testbed to create proper test cases
 - Different Use Cases CA only implementation
 - Different Use Cases for EO only implementation
 - Granularity: Per Process (P001, P002, P003)


INTERPLAT STATUS - Vortal

- What is implemented (Processes and Transactions)
 - P001, P002 and P003 implemented and supported at the eDelivery side.
 - At the platform side, in the last phase of proposal submission integration (P003).
- Status on e-delivery deployments
 - AP for Vortal deployed and is live, and with an SMP registry for testing purposes.
- Testing status
 - Test bed from PEPPOL passed successfully
 - Planning to exchange messages with BeschA this week (14th)
 - Sporadically testing with the Nordic consortium,
 - Problems with the description of the messages.
- Next steps
 - The plan is to install the interoperable version of our platform on the 29th of November in a Pre-Production environment and start testing end to end with eVergabe.
 - Go live on the 21st of December and be audited by CEF in that week.



INTERPLAT STATUS - BeschA

- What is implemented (Processes and Transactions)
 - P001, P002 and P003 at the eDelivery side. At the platform side we are now in the last phase of proposal submission integration (P003) which is already available as a preliminary verson.
- Status on e-delivery deployments etc
 - AP for BeschA is deployed and is live, and with an SMP registry for testing purposes.
 - REM-Evidences already implemented.
 - Need to sign the PEPPOL eTendering Agreements.
- Testing status
 - Test bed from PEPPOL passed successfully,
 - exchanged few messages with Vortal
 - will intensify the testing during the next weeks.
- Next steps
 - The plan is to install the interoperable version of our platform on the 29th of November in a Pre-Production environment and start testing end to end with Vortal.
 - Go live on the 21st of December and be audited by CEF in that week.
