PEPPOL testbed 1.0



- Peppol testbed 1.0
 - For onboarding Peppol Service Providers in AS2 and AS4
 - Self service where testers interact with the testbed without human intervention. Certificates are used as login credentials
 - Applicable to all new service providers before issuing of production certificates
 - Currently only one AS4 implementation in the testbed: Oxalis 4.1.0-RC9
 - About to go under migration from version 1.0 to 2.0

Peppol Testbed 2.0



- New AS4 eDelivery test suite available from 21st October
 - Any on-going 1.0 test suites needs to be completed before this date from this date the 2.0 test suite is mandated (to get approved for a production certificate)
- Contains the 4 test cases from Testbed 1.0 (these will be improved)
 - Receive Invoice (upgraded to BIS v3)
 - Send Invoice (upgraded to BIS v3)
 - Receive large Order (upgraded to BIS v3)
 - Send Large Order (upgraded to BIS v3)
- Adding 2 new test cases
 - Simulate "man in the middle attack"
 - Revoked or invalid certificates in the SMP lookup
- Doing the AS4 onboarding test will give providers AS4 accreditation on PEPPOL.eu and permission to do AS4 in production

Current AS4 status in Peppol



- 31 AS4 certified PEPPOL Service providers (as of 11-10-2019)
- 25 providers are doing the AS4 test
- 234 providers haven't started the AS4 test yet!



AS4 migration plan – responsibilities and main dates

Currently in T3 transition phase

- New Service providers may choose to only support AS4 (Germany, Lithuania, New Zealand and Australia only accept AS4)
- Existing service providers are still mandated to support AS2 and AS4 is optional

• After February 1st 2020

- All service providers must support AS4
 - SMP registrations must have AS4 as a minimum
 - Sending Service providers need to have AS4 capabilities as a minimum
- AS2 becomes optional
- After transaction volume on AS2 drops below 20%
 - Phase out date for AS2 will be announced

AS4 migration – important info



- Not being AS4 certified by February 1st
 - Not allowed to do AS4 in production
 - Compliance breach will be reported to responsible PEPPOL Authority
 - PEPPOL Authority will follow and act according to PEPPOL compliance escalation
- Receivers not being AS4 capable

Compliance breach will be handled by PEPPOL Authority

OpenPEPPOL will start monitoring this

Support when implementing and testing AS4




- Your Software implementation vendor (can be limited with OpenSource)
- EC (mainly for Domibus but also detailed AS4 knowledge)
- OpenPEPPOL service desk (mainly for extracting logs on your and high level support)
 - Be as detailed as possible when asking support in the Peppol service desk
- Market experts and consultants
