**Brief personal statement setting out the reasons why the candidate should be elected:**

I have been close to the eInvoicing topic since 2000. I have been country representative in CEN eInvoicing workshop for several years, I've been the project manager in launching Estonian country-wide eInvoice register portal ([www.arved.ee](http://www.arved.ee)) in 2005, I have first launched eInvoice receiving services and digital invoice workflow concept in Estonia in 2008 and I have been member of the Estonian eInvoicing Workgroup.

On the International level I have been related to E-Invoicing since 2008. I have been OpusCapita representative in EESPA (European E-Invoicing Service Provider Association) since 2013 and in OpenPeppol since 2016. Since June 2014 I am member of EESPA Executive Committee – I am mainly active in interoperability working group. Since 2015 I am Estonian representative in CEN TC434 and was active participant of the syntax as well semantic model workgroups. Since 2017 I am member of EMSFEI – European Multistakeholder Forum on E-Invoicing.

My activities in Peppol have been mainly related to Post-Award Community. Years 2016-2018 I was the project lead for Invoice Response Message project. Since 2017 up until now I am the member of OpenPeppol PoAcc CAB. Last 2 years I have been Peppol Management committee member as Service Provider representative and since spring 2019 I am also leader of Peppol Service Provider Community.

In OpusCapita I am responsible for E-Invoice Network development activities globally.

I would like to apply for Post Award Change Management Board member.

I have been contributing actively to OpenPeppol community. I have been driving Invoice Response Message implementation – as a result of that work we have common European wide standard for Business Level Response on Invoices. I have been participating actively in Management committee work. I was the person who initiated the potential usage of Peppol Network in CTC (Continuous Transaction Control) countries – as a result of this work Peppol is now developing the first PoC around that area. I have also been representing Peppol in GIF-group (Global Interoperability Framework) where different industry bodies are agreeing common interoperability framework for the world. Last year (2019) I have been starting the work of the biggest member community we have - Service Provider Community and been successful in that.

I have also been active member of Peppol Post Award Change Management Board and have always tried to bring more business rational into the work of such a technical body.

Considering my career in one of the leading Service providers in Nordics, long experience in different subject matter organisations as well my geographical background, I hope I can benefit to this position with a good combination of the eInvoicing knowledge from different industry organisations, Eastern Europe economy and also long professional experience in particular field at the same time.
